Requirements

- The scholarship may be a direct donation or acquired through fund raising
- The donor must sponsor, assist and be actively involved with any fund raising activity
- The scholarship and any fund raising activity must adhere to *The Nicol Foundation (TNF) Mission*
- The scholarship and any fund raising activity must be approved by the institution (school, church, or organization) and TNF Board of Directors
- A scholarship cannot be fully granted until all required funds are submitted
- The scholarship recipient must be independently evaluated and selected by an agreed upon method of the TNF Scholarship Committee and school/church/organization
- Donations are tax-deductible and non-refundable upon receipt and deposit by TNF
- The base scholarship is \$1,000
- The perpetual scholarship may vary in value over time. The goal is to grow in value and distribute roughly 3-5% annually (depends on investments, cost factors and sponsoring institution requirements)
- Honoree will also receive a certificate/plaque to commemorate the recognition
- Donations consist of the scholarship plus donation for processing funds to help other TNF educational projects
